	earmarked for? Investment policy, which are guidelines. Short-term (operating expense), mid-term and long-term (5-10 years) buckets of money. Long-term use that money in a money manager which would be a mutual fund most likely. Investment Policy is the critical and then figuring out how to invest the money. What are some ratios for the different terms. Typically, 50% equity split. There's usually 15% in money markets for short-term investments. Mostly, it's always good to investment. There's a 1% or 1.25% fee to manage it, as the accounts get bigger the fees go down. His minimum is typically \$100,000. Working with organizations, he can get referrals so it's worth his time. Likes helping out schools. CDs could yield a few hundred dollars vs. a few cents.		
	JEF goal to invest our money, long-term to help earn funds in the future. What's the process? How much money?		
	In a mutual fund, the money is not locked in, can have a check within 3 days. Dividends can be sent out. Could use the dividends to reinvest. Give it at least 5 years, that's where you get the compounding interest and take a decade.		
	Different types of foundations, typically 5% of endowments would be taken out, you could do more but need to adhere to taxes, etc.		
	Change in board members, they would have to redo the paperwork.
